Position Objective

- Support the IPC Health vision to provide high level, quality occupational therapy care and intervention to the local community.
- Work as a member of a multi-disciplinary team, with the utmost skill and sensitivity to meet individual and community needs.
- Work within the social model of health and with the broader team to address identified problems with the clients.

Key Responsibilities

- Provide direct service to clients, including health education, therapeutic management and health promotion.
- Develop, implement and evaluate primary care and health promotion activities and services in accordance with organisational priorities and expectations.
- To participate in regular clinical supervision from an Occupational Therapy Senior Clinician according to the organisational supervision policy.
- To provide clinical supervision to Grade One Occupational Therapists according to the organisational supervision policy.
- To participate in student supervision as required.
- Work at all times in accordance with service philosophy, policies and procedures.
- Commitment to ongoing clinical professional development and evidence based practice.
- Responsibility for an occupational therapy portfolio.
- Maintain comprehensive (including assessment, intervention and care plans) and up to date client records and ensure their safe custody and confidentiality at all times.
- Prepare and maintain appropriate statistical data, reports and analyses for activities and services for which responsible and make recommendations as appropriate.
- Provide advice in areas of responsibility and professional expertise as circumstances require and as requested.
- To use effective interpersonal skills to enhance collaboration both internally and externally.
- To approach conflict in a respectful, open and reflective manner and to regard it as a learning opportunity.

- To attend and actively participate in campus, program and discipline meetings and activities.
- To identify, develop, implement, and evaluate quality improvement initiatives.
- To participate in the development of policies and procedures for areas for which responsible and participate in the development of organisational policies and procedures as required.
- To participate in occupational health and safety training and risk management activities as relevant to the role and as required.
- To participate in and coordinate as delegated, professional development and training activities.

Key Selection Criteria

- Bachelor of Applied Science (Occupational Therapy) or equivalent.
- Minimum of two years experience working as an Occupational Therapist preferably in community health.
- Special knowledge or depth of experience in a range of conditions that Occupational Therapists manage.
- An understanding and commitment to the principles of community health.
- Ability to work autonomously as well demonstrated capacity to work as a member of a multidisciplinary team in the delivery of services to the community.
- Demonstrated capacity to provide effective clinical supervision.
- Excellent communication, negotiation, organisational and time management skills.
- Able to liaise across the full spectrum of health and welfare services.
- Proficiency in technical skills and ability to use client management systems.
- Current and valid registration with the Australian Health Practitioners Regulation agency.
- Registered with State-wide Equipment program (SWEP).
- Current and valid Victorian Drivers licence and Working With Children's Check.

Other Information

- This role is subject to a satisfactory National Police History check.
